The Spirit of Liberty Foundation and Lahaina Yacht Club Launch International Campaign to Rebuild After Maui Wildfire

The Spirit of Liberty Foundation, a 501(c)(3) nonprofit organization dedicated to honoring and supporting America's real Heroes—our Armed Forces, Veterans, First Responders, and helping Victims of disaster, immediately created and initiated a fundraising campaign to support Lahaina Yacht Club and its affected employees after the Lahaina Yacht Club was destroyed in the August 8, 2023, wildfire.

In a short time, the campaign has raised nearly \$200,000 from Yacht Clubs across the Country contributing the urgently needed funds.

Now, the Spirit of Liberty Foundation has created a “*Save the Lahaina Yacht Club Auction*” expanding our efforts globally with an ambitious international campaign aimed at raising millions of dollars to fully rebuild the club and restore its vital role in the community.
